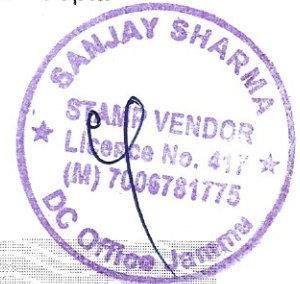
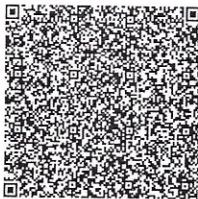

1. That the Model Institute of Education and Research has passed a resolution in the Governing Body meeting of the MIER College of Education on **September 3, 2020** for submitting the application for recognition of B.Ed. and M.Ed. courses in the name of MIER College of Education (Autonomous) with intake/additional intake under Section 14/15 of the NCTE Act, 1993, to the NRC, NCTE and as per this resolution the institution has submitted this application **File No: F.No.NCTE/NRC/FR-2122-NRC-50552205** (A Copy of the resolution is attached).
2. The **Model Institute of Education and Research** has applied for two courses (**B.Ed.: Two Units and M.Ed.: One Unit**) on the land for which land documents have been submitted with this application, **File No: F.No.NCTE/NRC/FR-2122-NRC-50552205** as per clause 8(2) of the NCTE Regulations, 2009. Additionally, there is no application pending with the NRC for decision, and the Society/Trust/Company has submitted no other application with the said application to the NRC, NCTE, New Delhi.
3. That the land & building of the institution for the proposed teacher training programme with this application, i.e. **F.No.NCTE/NRC/FR-2122-NRC-50552205** are exclusively meant for running the proposed teacher education programmes, i.e., **B.Ed. and M.Ed. courses**, and the institution has a well-demarcated land area as specified by the norms. The Society/Trust/Company also undertakes that the maximum intake capacity of the institution for all Teacher Education courses, including the above application, for which recognition/permission is granted by the NRC, New Delhi, shall not exceed 100 for B.Ed. course and 50 for M.Ed. course as per clause 8(3) on the NCTE Regulations, 2009.
